# **Delegate Report**

Panel 71, Area 42 Delegate Julie C.

Hi everyone, my name is Julie C. and I have the honor, privilege and pleasure to serve as the Panel 71 Delegate from Nevada Area 42, which of course includes our sliver of Eastern California. I stand before you today with mixed emotions. I am so very grateful that you trusted me enough to represent your voice at the Conference. You gave me the opportunity to participate with delegates, trustees, and staff from all over the U.S. and Canada. It is a huge responsibility and one that I have done my very best to do honor you. Looking back over the past nearly two years, I believe I was blessed with such an amazing experience. I participated in one of only two ever held virtual General Service Conferences and then was able to attend in person this year. It has been very hard for many with the finances, little travel, difficulty providing services and outreach and of course the supply chain and the office closure. I feel extremely privileged to have served as delegate during such a challenging time.

How many of you are at your first assembly? Welcome, we are so grateful you are going us.

How many of you are at your first general service meeting - you haven't been to a district or GSR meeting, you haven't been to either a NAGSC (Northern NV) or SAGSC (Southern NV) meeting – this is your first time meeting us? Welcome to Tonopah, NV. I hope you find here what many of us have found. My world opened to the big world of Alcoholics Anonymous. It really opened my eyes to all the suffering alcoholics who haven't yet found their way to our rooms. I knew what to do when we had a newcomer, but what about all those suffering that haven't made it yet to the rooms? How do we reach them? For those of us who have been here a while, let's make sure we take some time this weekend to welcome our first-time participants.

So, I am the delegate for Nevada, at least for three more months. Over the next hour, I hope to recap the Annual General Service Conference meeting, I was privileged to attend in April. I gave my report in both the South and North, but this is the first time we have met as entire area since I have been back from the 72<sup>nd</sup> General Service Conference.

I have printed copies of the quick reference sheet, which lists all the items that were voted on by the full Conference and all that are listed as passed are considered now as the "voice" of Alcoholics Anonymous. For this presentation, I am including many items, but have left out some that have more impact on the process of the General Service Conference. Typically, we have paper copies of the final report at the Fall Assembly. However, due to the ongoing supply chain issue, they are not yet available. Mike L, our webmaster, has uploaded both the Spanish and English reports to the "Delegate's Corner" on the website. I am deeply sorry for any inconvenience.

Here is the recap of the 72<sup>nd</sup> General Service Conference:

The structure of the Conference shows the A.A. Groups on the top and the General Service Board on the bottom. For those of you familiar with an organizational chart, this shows that the final authority and ultimate responsibility lie with the A.A. Groups — not the General Service Representatives, but the groups themselves. So, you see, it is vital for groups to be involved in providing their voice as they hold the final authority.

It isn't feasible for all groups to attend the General Service Conference, so communication is how we get the voice from the groups to the General Service Board. We are still improving on our process to communicate the agenda items to the groups.

#### In Nevada:

- Communicate about the items to be discussed at the General Service Conference:
  - Provide access to all the background on our anonymity password protected page on the nevadaarea42.org website.
  - Ask all members to participate on an area conference committee, to get more involved.
  - Provide presentations from area conference committee members in the North,
     South and at the Pre-Conference Assembly, here in Tonopah.
- Get a group conscience
  - Hear the voice of the group through general service representative, GSR
    - Sense of the assembly
    - Online survey
- Delegate brings the voice to the Conference
- Brings the voice of the Conference back to the groups
  - Delegate report backs Southern Area and Northern Area meetings, plus any requests from districts or groups within Area 42

What is the General Service Conference? While the General Service Conference operates all year round, the annual meeting, usually held in April, is the culmination of the year's activities, the time when the collective group conscience of U.S./Canada A.A. comes together to take actions that will guide the groups in the years that follow. (A.A. Service Manual, page 39)

#### Conference? Who makes up the conference

This year there are 133 voting members of the General Service Conference acting together as guardians of A.A.'s World Services and of the Steps and Traditions. They are composed as follows:

- 93 Delegates (70%)
  - FUNCTION: Represent A.A. groups in fulfilling the ultimate responsibility for A.A.'s World Services.
    - Traditionally, Delegates constitute at least two-thirds of the voting membership.
- 26 Trustees, A.A.W.S. Directors, GV Directors. (20%)
  - o FUNCTION: Responsible for policy and implementation.
- 14 General Service Office and Grapevine Staff (10%)
  - FUNCTION: Carry out policies of and report to the General Service Board and Conference.

Historical Trip: The Pacific Region and Western Canada Region usually charter a bus and ask our archivist to take us for a historical AA ride. A few places we saw were:

- Brooklyn 38 Livingston Street Bill and Lois' home during the flush, high-flying years on Wall Street, from 1926-1929
- Brooklyn 182 Clinton Street Lois' family home. Lois' father gave the home to Bill and Lois, and it is where he got sober. In 1935 Bill began hosting meetings at the house on Tuesdays.

- Manhattan Charles B Towns Hospital. 293 Central Park West. Dr. William Silkworth, Medical Superintendent at Towns, treated about 40,000 alcoholics there, including Bill W., and wrote the "Doctor's Opinion" in *Alcoholics Anonymous*.
- Manhattan Calvary Episcopal Church, Park Ave South, Manhattan. Bill attended the Oxford Group meetings here with Ebby T. Samuel Shoemaker, source of AA's spiritual principles via the Oxford Group, was the pastor.

Where do agenda items come from?: The final agenda for any Conference consists of items suggested by: Individual A.A. members; Groups; Delegates; Trustees; Area assemblies; Area committee members; or Directors and staff members of A.A.W.S. and the Grapevine.

What happens to the agenda items at the General Service Conference?

- There are 11 primary committees and 2 secondary committees.
- Delegates are randomly assigned to a primary committee and some delegates are also assigned to a secondary committee.
- Each Conference committees discusses their agenda items.
- The Conference committees either decide to recommend an agenda item, issue an additional committee consideration, or take no action.
- If committee decides to take no action, it is the end of the road for the agenda item.

How agenda items become advisory actions:

- COMMITTEE RECOMMENDATIONS
  - Each Committee presents its recommendations
- FLOOR ACTION
  - During the general sessions, members may make recommendations directly from the floor
- VOTE BY THE FULL CONFERENCE
  - Passes with substantial unanimity or
  - Fails with less than 2/3 majority
- ADVISORY ACTION
  - When a recommendation is approved it becomes an Advisory Action

Here are the advisory actions from the 72<sup>nd</sup> General Service Conference grouped by type rather than specific committee.

Approved updated literature:

- The following updated pamphlets were approved
  - "Young People and A.A."
  - o "Is A.A. for You?"
  - o "Is There an Alcoholic in Your Life?"

- o "Frequently Asked Questions About A.A."
- o "This Is A.A."
- The pamphlet "Questions and Answers on Sponsorship" revision to add text regarding safety and A.A. was approved.
- The revised booklet *Living Sober* was approved adding a paragraph regarding safety and A.A.

More changes to pamphlets & other literature – these are from various committees as a result of equitable distribution of workload. This is an experimental distribution to even out the workload so that committees share as equitably as possible.

#### Literature

- The pamphlet "Twelve Traditions Illustrated" be updated with non-offensive, contemporary text and illustrations.
- Continue to make edits to the draft pamphlet The "Twelve Steps Illustrated".
   (passed through Floor Action)

#### • Public Information

- The revised pamphlet 'Understanding Anonymity" was approved.
- Retire the outdated "A.A. Fact File".

#### • Treatment & Accessibilities

 Add the Long Form of Tradition Five to the pamphlet, "The A.A. Group" in the section "What is an A.A. Group?" at its next printing.

#### Trustees

 Revise the pamphlet "Do You Think You're Different?" to update the stories to represent greater diversity.

#### AA's 12 Concepts for World Service explained

The video animation of the pamphlet "The Twelve Concepts Illustrated" (currently published by the General Service Board of A.A. Great Britain) be adapted and produced by the Publishing Department.

#### **PUBLIC INFORMATION: 2022 MEMBERSHIP SURVEY**

- Format changes, two new questions and six changed questions on a 2022 membership survey questionnaire.
- A 2022 A.A. Membership Survey be conducted with a budgeted cost not to exceed \$20,000.
- The 2022 Membership Survey questionnaire receive final editorial review by the Trustees'
  Public Information Committee after consulting with our professional survey methodologist,
  to address concerns raised by the 72<sup>nd</sup> General Service Conference related to the survey
  questions about Racial and Ethnic Background, and Employment Status. (passed through
  Floor Action)

**TRUSTEES:** We elected our new Pacific Region Trustee, Reilly K. She is from Oregon, has 56 (or more) years of sobriety. I have had the pleasure to serve on an ad hoc committee with Reilly. Hopefully next year you will get a chance to meet her either at the Pacific Region AA Service Assembly in LA in March or here at one of our assemblies. Phil W, was the candidate from our Area and I am grateful for his willingness to serve. Being a Regional Trustee is a big position with huge time commitments and responsibilities.

#### 2023 GENERAL SERVICE CONFERENCE

Please bring these themes and topics back to your groups and districts. As you plan for next year functions, these are the spiritual concepts that will unite all our groups within our U.S./Canada Conference.

I would like to specifically discuss what happened during the final floor action late on Friday evening.

<u>Floor Action #9:</u> It was <u>recommended</u> that: The 1995 Conference Advisory Action be reaffirmed that the first 164 pages of the Big Book, the Forewords, "The Doctor's Opinion," "Doctor Bob's Nightmare" and the Appendices remain as is.

So, the history is that prior to the decision to publish the 4<sup>th</sup> edition of the Big Book, the Advisory Action was passed. During the process of the 4<sup>th</sup> edition, this Advisory Action was reaffirmed a number of times at the General Service Conferences.

Last year the wording of the Advisory Action was

A Fifth Edition of the Big Book, *Alcoholics Anonymous*, be developed, including an update of stories to better reflect current membership, keeping in mind the 1995 Advisory Action that: "The first 164 pages of the Big Book, *Alcoholics Anonymous*, the Preface, the Forewords, 'The Doctor's Opinion,' 'Dr. Bob's Nightmare,' and the Appendices remain as is," and that a progress report be brought back to the 2022 Conference Committee on Literature.

Pending its development, the draft Fifth Edition of the Big Book would include a new foreword, an updated preface and updates to expand on existing ideas in Appendices III and V.

So, in effect, this floor action is about Appendices III and V, which are the "The Medical View on A.A." and "The Religious View on A.A.", respectively.

After many comments, some not so nice, about the need to keep the Big Book untouched. One person said their area had lots of people afraid that we were going change everything in the Big Book. We were going to take God out, degenderize, etc. The delegate from another area said that if we were doing our job that our groups would know that we said we wouldn't change anything. You can see that the discussion had nothing to do with the floor action.

But the discussion was necessary. Why, because the 71<sup>st</sup> General Service Conference made several changes that many of the groups are not in agreement with. Like changing the A.A. Preamble and the *Twelve Steps and Twelve Traditions*. Even though the discussion was off topic, it was right on que. It was late at night, we were exhausted. Thirty to forty percent were coming down or already had Covid, including yours truly (I wasn't aware!). Insults were thrown, lines were drawn, and the truth finally was on the table.

In my opinion, we had already reaffirmed the 1995 Advisory Action last year with the words "keeping in mind the 1995 Advisory Action". This Advisory Action seemed pointless and felt like it we were going backwards.

Someone recommended an amendment to adding the appendices to remain untouched. During the discussion I learned that one of the doctors we quote in Appendix III was involved in eugenics during the 1930s and 40s. And that we voted in 2021 to review the two appendices for good purpose. Not to necessarily change, but to look at and update if appropriate and necessary.

We had amendments recommended and we voted to keep the original wording. As I listened to all the passion and hurt, I saw that many delegates wanted this to pass so that they could go back to the areas and assure their groups that our precious Big Book is safe. I voted yes, but the floor action failed. I was in the minority, so I spoke to the Minority Opinion. I told them that I felt the groups in my area were aware that the first 164 pages were safe. I trusted our trusted servants to protect the book that I so dearly love and know they too love our Big Book. However, for the sake of unity, I voted in favor for the sake of unity. That if other delegates have members with the perception that our Big Book is at risk of being changed, I would vote in favor for unity. Many others spoke of other reasons for the item.

Then our new Class A (non-alcoholic) Trustee Treasurer asked for the question to be reconsidered, in other words a revote. We voted to revote, but then the discussion began again. One of the GSO staff spoke that we already had an Advisory Action from 2021 asking that we look at the two appendices and when the 5<sup>th</sup> Edition is ready to be approved that Conference will have to deal with the conflict if we pass this recommendation. Another delegate spoke that he wasn't comfortable leaving a mess for a future Conference to clean up. We voted again and I changed my vote to no, based upon the two speakers just mentioned.

The reason I am mentioning this is to show you and example about how valuable discussion is. It allows us to have an informed group conscience. Even though there were insults, lines drawn, and "us vs them" attitudes, by the end of the night, there was unity. I believe everyone had time to voice their heart and to be heard. Let's always remember that when we have disunity, please just talk some more. Conference ends at 8:42 p.m.

On Saturday afternoon, after the close of the Conference, we were invited to the General Service Office. The first visitors allowed in since March 2020.

- A friend of AA, Sister Regina road her motorcycle from village to village talking to the priests to start Alcoholics Anonymous in Paraguay.
- Another way to look at our reserve fund is: The reserve fund is a balance between the needs of today and the unforeseen needs of tomorrow.
- We never want to step over a drunk to argue about the Traditions.
- Rather than continually doing outreach to the groups not here, don't neglect the groups that are.

#### Questions to ponder:

- How much of our support are we comfortable coming from our literature?
- In Europe one member drove around with smart phones and tablets so that members could connect. What can we do to help people who are still struggling from the pandemic?
- How strong is my group participation, in service and support? What more can we do?

IMPACT OF PANDEMIC ON GSO REVENUE DISTRIBUTION: In 2016 through 2018 our literature sales were double our contributions. In 2019 literature dropped significantly (I'm not sure why). Then in both 2020 and 2021 our contributions and literature sales were nearly equal. Contributions increased around \$2 million, but our literature sales drop by over \$5 million. This is why we needed to use our Reserve Fund. And why we have not been able to replenish the fund. Please keep in mind that the world has not recovered financially, nor have we.

It is now time to talk about rotation. This weekend is an election assembly. My second assembly as a GSR was an election assembly. I had no idea who to vote for. It is important to vote for the person you feel is most qualified. What does that mean? For me, it isn't about voting for the person who's "turn" it is or who I like more, or who I know better. It can be hard to determine who is most qualified, but if you vote based upon what you know and have seen, what they tell you today and perhaps council with your higher power, then that is all we can ask. There is a saying here that we "qualify the called rather than call the qualified". I have seen people with limited computer skills be successful secretaries. They asked for help and maybe worked harder, but they were willing and ready to Area 42 and did what it took to serve us.

I would like to tell you a story about when I didn't choose the most qualified. It was at the Conference. I thought this one person would be the best person for the position but wanted to choose someone from a different region. It felt to me that there were too many people from this one region. So, I voted for a person from a different region. If I had voted for the most qualified it would have been a tie, but because I voted for the other person, the most qualified was not elected. I regret my vote. Unfortunately, the person elected has done nothing. There

has been no communication and I made a mistake. I convinced myself it was for the good of A.A., but I was playing regional politics. Please choose wisely.

Lisa has asked us to discuss what our position entails outside of what the *AA Service Manual* and our Area 42 Guidelines say. For those of you planning on standing for delegate, what I really want to express is the time commitment this position takes. Please follow the suggestion in the *AA Service Manual* when it suggests that you should discuss with your family and employer prior to standing for delegate. You can ask Lyle or Laura, who can tell you their experience as significant others to the delegates what they observed. Don't get behind in your emails. There is significant computer usage. If you are not as comfortable with a computer, plan to get support. We don't require any specific skills to stand for positions, but hopefully a willingness to learn and an ability to ask for help. We have some extremely qualified people who hopefully will stand today.

In Area 42 we have alternate positions for all of our area officers. I started as an alternate in all of my positions. I was the alternate DCM before the DCM, the alternate chair before I was thrust into area chair mid panel and alternate delegate before delegate. I have been blessed with great partners and friends, whether I was the alternate of the primary. Leaning on each other really helps our area in unity. Don't dismiss standing for alternate.

It has been such an honor to serve Nevada Area 42. It is a tremendous commitment of time and effort. For me, with the Dixie fire last year and some current health issues, I have sometimes struggled to keep you as informed as I would have liked. This has been an experience of a lifetime. Mainly, because you trusted me enough to be your voice. From a screaming baby who had abandonment issues, to a nerdy kid with no friends, to an undependable drunk with a temper to representing an area at the General Service Conference. How does that happen? From you. You inspired me to want to serve Alcoholics Anonymous. You showed me how to dig deeper within to find the courage to stretch and learn new ideas. You loved me when I made mistakes. You forgave me when I was wrong. And you trusted me with your voice. I will be forever grateful and can never pay back the gifts you have given me. You all are in my heart and will be with me as I move onto my next position, whatever that may be.

### Registrar

Hi I'm Paul an alcoholic and your Area 42 Registrar. It has been an honor my pleasure to serve these past almost two years and look forward to working with the newly elected Area 42 Registrar for the rest of this year. The group change forms, the new group forms, and the DCM change forms are available on our nevadaarea42.org web site, under the section "Manuals, Guides & Forms". Just click on the form and download it, then you can fill it out and send it to me at registrar@nevadaarea42.org . Please, please, please, send it to me and not GSO, this way I know which groups have been updated in our Area and if there are any problems we can fix them right away. I know it states at the bottom of the form that you can send it directly to GSO, but several that have been sent in directly have had missing information which had to be updated. As of 9/11/2022 we have 13 registered virtual groups spread out in 6 Districts, some of those are still pending. On to some assembly information we had 187 members pre-register, with 133 to be in-person, 54 to be virtual and 106 advance banquets sold. Our total numbers for the assembly are 243, with 189 in-person and 54 virtual and we have 205 voting members.

Our Area chair Lisa has asked us to list some of our duties that are not in the Area 42 guidelines. Here is what the guidelines state.

# Duties of the Registrar:

- 1) Maintain a current mailing list and phone numbers of all members of Area Assembly.
- 2) Coordinate with GSO, the Area 42 Delegate, and DCMs to maintain current information of all

groups in Area 42.

- 3) Coordinate efforts at Area Assembly and Committee meetings to accomplish responsibilities
- of Area Registrar.
- 4) To have registration packets as well as necessary materials for registration at the area

assembly, including bringing area's laptop.

What the Registrar does that is not in here:

- a) Keep a count of the voting members at the assembly, both in-person and virtual.
- b) Set up pre-registration and early sale of banquet tickets for in-person and virtual.
- c) Show up a couple of hours early to set up the registration tables with the Alternate Registrar to check in members when registration opens, which is a couple of hours before the assembly starts. So in total this is about 4 hours before assembly start time.
- d) Sell banquet tickets at the assembly.
- e) Order materials as needed for assembly registration (badges, ribbons, ink for printing badges, etc.) Thank you for allowing me to serve, Paul

What I need from the members of Area 42 right now is to be patient and wait for the process to happen. We are in contact with other members that have been through this process before and are welcoming their advice and direction. This is very Important, Please Please Please, Do not reach out to possible facilities on behalf of AA. If we are chosen GSO has a process that will take bids and do negotiations with all possible locations and facilities. Truly our only job will be to put together 4000 volunteers to help at the conference. Thank

you again for your time. We will see you in the Spring.

# **Charging for Area Assembly**

### Chair Michele M.

This ad hoc committee was asked to determine the need of the area to charge for the area assembly twice a year.

Michelle M., Paul E., Sophie K., Jonelle W., and Caroline T.-J. served on this committee.

This ad hoc committee recommends waiving assembly registration fees for a trial period of up to three years. Our recommendation is based on our survey of other N. American conference areas, our discussion of the financial implications, our desire to be of service to the groups and to encourage participation in General Service at the area level.

We reached out to 10 areas across our North American conference to learn if they charged a registration fee for their assemblies.

- 7 of the 10 areas replying do not charge a registration fee
- 7 of the 10 supply name badges; most supply printed materials, as well
- 7 of the 10 hold two or more assemblies per year

We discussed the financial implications for Area 42's suspending a registration fee. We asked ourselves:

- What do registration fees cover?
  - Registration fees are not designated towards specific expenses. They assist in the overall assembly budget.
- If we waive registration fees how much money are we talking about absorbing?
  - Based on actual expenses Sept. 2018 January 2020 (pre-covid) assembly costs have varied from approximately \$3,000 \$4300 per assembly. With two assemblies per year, we're looking at absorbing from \$6000 \$8600 per year for a trial period of up to three years.
- Can the area afford to do this?
  - With a current surplus of more than \$60,000 we can try this one year at a time for up to three years probably without financial problems.
  - The finance committee can be asked to review the continued feasibility of the plan.
- Why should we consider this recommendation?

- Area 42 has no stated A.A. purpose for thousands of dollars in group contributions that exceed our prudent reserve. (See the long form of 7th Tradition.) It would be a service to the groups sending GSRs to the assembly to suspend registration fees.
- In waiving registration fees, Area 42 could attract AA members new to General Service to participate more readily. AA members and guests to our assembly might feel more welcome.

### • Why shouldn't we consider this recommendation?

- There may be other ways to serve the groups with financial support. For example:
  - Provide a light lunch on assembly Saturdays? Offer a free banquet ticket?
  - Increase funding available to GSRs for assembly and/or other General Service event expenses?

These were the ad hoc committee's considerations in looking at suspending assembly registration fees. This ad hoc committee recommends waiving assembly registration fees for a trial period of up to three years.

Thank you for allowing us to be of service.

### Motion

Following the ad hoc committee's report, a recommendation was made to waive assembly fees for a trial period up to three years.

Discussion followed.

Some thought it was a good way to relieve some of the burden of the assembly from the groups. Someone said it was a good way to get people here and involved. Minority opinion said it would not make much of a difference. The timing is bad with the new combined Area 42 treasury with the groups cutting their pies - a lot of unknowns.

First vote - majority ruled.

Second vote - majority favored with substantial unanimity.

Motion carried.

### La Vina

The La Viña Ad Hoc Committee proposes the creation of two (2) La Viña committees complete with Chair positions, one in the North and one in the South. The purpose of this proposal is to bring La Viña into parity with NAGSC and SAGSC Grapevine committees. The La Viña committee chairs' duties would be the same as the Grapevine chairs and will be to represent La Viña at Area, SAGSC and NAGSC events. The La Viña Chairs should be fully funded, voting members of the area committee. The newly formed NAGSC and SAGSC La Viña committees should be included in the Area budget process.

As our Area grows and matures it is time to recognize the value, passion and efforts of those who have been carrying the La Viña message and give them parity with the Grapevine committees efforts. The area Ad Hoc committee is tasked with recommending ways to create parity.
