This Assembly will be both in-person and virtual. Message from our SAGSC Chair

Spring is in the air, and the first sure sign of spring is the blooming of the General Service Conference Agenda Items! Their “due date” is tomorrow, so watch your email and texts for word from our Delegate and Alternate Delegate as the Agenda Items are disbursed to the various Area 42 Conference Committees (ACC). The committee volunteers get to read and summarize each Agenda Item. It is a very interesting process, and if you don’t have a seat yet on one of the Area Conference Committees, reach out to our Delegate or Alternate Delegate through the www.NevadaArea42.org website. Our Delegate will pick approximately 5 Agenda Items for us to take to our groups. There are usually 5 Agenda items in the South, 5 in the North, and another 5 at the Area Assembly in April. We will discuss the Southern Area Agenda Items at our SAGSC Roundtable on March 17th. The NAGSC (North) meets on March 16th to discuss their 5 items and we are welcome (and encouraged!) to attend their meeting online. Details will be forthcoming. We give our Delegate our groups’ feedback on the items and he takes that information with him to New York and the General Service Conference and then acts in the best interests of Alcoholics Anonymous as a whole. I love the way AA works. Sometimes it looks like complete chaos, but then the dust settles, the sun comes out, and the garden is in full bloom. Yes!

Our Southern Area Committees have been very active and all of them need volunteers who are seeking meaningful work, lots of laughter, and enhanced sobriety:

- Accessibilities is recruiting members to its Meetings To Go sub-committee. Meetings to Go takes meetings to AA members in nursing homes, group homes, hospitals, rehabs – wherever we are. They include District 21 and reach out to Native Americans.
- Archives meets most Saturday mornings at Central Office. The new fire-proof safe is on the way! Volunteers are always welcome. Playing in the Archives is like a Treasure Hunt. You never know what goody you will find!
- Cooperation with the Professional Community (CPC) has been working closely with, and making presentations to, the Nevada National Guard, and staffed a booth at a GSO-sponsored convention about disaster preparedness. A lot of alcoholics make it into our rooms because a professional (therapist, teacher, judge...) recommends that we seek help with our drinking. CPC cooperates with the professionals to let them know what we do, and don’t do, and how to access our program.
- Grapevine and La Vina are everywhere! District workshops, Service Festival, Roundup, visits to groups, writing workshops. Whew!
- Las Vegas Young People in Alcoholics Anonymous (LVYPAA) are hosting events, putting on conferences, performing in plays, playing well with others all over our Pacific Region – and beyond!
- Public Information (PI) is keeping up with pamphlet racks all over the valley, and working closely with CPC and PI in the North and South.
- Hospitals & Institutions (H&I) – is not an Area committee per-se, but does outstanding work reaching out to alcoholics in treatment and correctional facilities.

Then there’s the Districts! Everyone is planning service workshops, fellowship picnics, and events. There are so many service opportunities, it can be hard to pick one – or two! Go to committee and district meetings and check out what they’re up to. Get out into the wonderful world of AA and bloom where you are planted!

Membership Survey Available!

In 2022 the General Service Office randomly selected and surveyed more than 6000 A.A. members in the U.S. and Canada, asking for responses to general questions that will help our members, the professional community, and others understand basic demographics and how our fellowship has changed over time. The survey has been conducted since 1968 and the last survey was done in 2014.



Members had the option to take the survey in English, French, or Spanish

Our current survey is the first time questions were asked about online meetings.

Other highlights include:

- **41% of A.A. members have been with the program for more than 20 years**
- **Members attend an average of two A.A. meetings per week**
- **75% of members have attended an A.A. meeting virtually (online or by phone)**
- **79% of members prefer in-person meetings**

Message from our Area Finance Committee Chair

Beginning January 1, 2023, through a series of guidelines changes at the Area level as well as at the sub-areas of NAGSC and SAGSC, our three treasuries have been combined into one account. The treasurers and the finance committees of all three entities, along with an ad hoc committee, worked diligently to see that this process runs as smoothly as possible. Everyone involved appreciates the patience of our members and we know there are still a lot of questions being asked. Keep those questions coming!! We are developing processes as we go and we need to know what works and what doesn't work with our new systems.

The main thing to remember is that groups will no longer send contributions directly to SAGSC or to NAGSC. Those contributions should now be sent to the same address as used to contribute to Area 42. That does not mean, however that those entities do not still need your contributions. We are still funding our NAGSC and SAGSC elected and appointed positions to Area Assembly and to PRAASA. Those entities still need group contributions in order to provide services to

the members through the standing committees. Contributions to SAGSC and NAGSC can now be combined with contributions to the Area. As an example, if a group has been contributing 50% of its excess 7th tradition to SAGSC or NAGSC, and 25% to Area 42; that group can now contribute once, 75% in one amount to Area 42. The Area treasury will fund your sub-area, NAGSC or SAGSC, through one centralized account.

Please continue to reach out to your treasurers and to the Area 42 Finance Committee members with your questions and shared experience. We want to know how this new accounting is working and how we can improve this important service arm of general service. Our Area 42 basket remains where "money and spirituality mix!"



AREA 42 TRANSLATION COMMITTEE GUIDELINES - proposed (first reading Spring 2024)

I. Purpose

The Area 42 Translation Committee will be responsible for keeping open communications, written and oral, between the Spanish Linguistic Districts and Area 42.

- A. The Translation Committee will coordinate and facilitate translation (written) and interpretation (oral) services. It will provide consecutive and simultaneous Spanish/English interpretation at Area Assemblies and pre-conference roundtables;
- B. Depending on the availability of volunteer translators and/or interpreters and equipment, the Area 42 Translation Committee will:
 - 1. Provide, upon request, consecutive and simultaneous Spanish/English interpretation at:
 - a. Area Committee meetings;
 - b. Area Standing Committee meetings;
 - c. NAGSC and SAGSC meetings.
 - 2. Provide written translation of Area 42 Assembly minutes, conference agenda item summaries, the newsletter, updates to the website and such other documents, reports, minutes or emails as may be requested by the Area 42 secretary or NAGSC or SAGSC secretaries in consultation with the Translation Committee;
 - 3. Provide written translation of Area 42 officers', SAGSC and NAGSC DCMs', committee chairs' and liaisons' reports;

II. Membership ~~Members and Meetings~~

~~The Translation Committee is to be a Committee which will consist of:~~

- ~~1. Chairperson~~
- ~~2. Alternate Chairperson~~
- ~~3. Committee members~~

A. Composition and Terms of Service - The Translation Committee will consist of a minimum of four members: three officers and at least one other member. The Chairperson and Alternate Chair must be bilingual English/Spanish and capable of interpreting and translating.

- 1. The Chairperson will be appointed by the Area Chair.¹
- 2. The Alternate Chair and Secretary will be elected from within the committee.
- 3. Translation Committee officers serve a four-year rotation. Rotation is strongly encouraged; however, individuals that hold positions on the Translation Committee may be asked to serve for more than one panel as circumstances warrant.

4. All Translation Committee members have one vote. In the case of an even number of committee members voting, the Chairperson does not vote.
 5. All are welcome to serve on the Translation Committee.
- C. Meetings – The Translation Committee meets monthly. Meetings of the Translation Committee are open to all.

III. OFFICERS

A. Chairperson

1. Facilitates carrying out the purpose of the Translation Committee;
2. Attends and conducts the meetings of the Translation Committee;
3. Attends Area Assemblies;
4. Prepares and submits quarterly reports to NAGSC/SAGSC meetings;
5. Secures translation and interpretation resources for Area Assemblies and Area Committee Meetings;
6. Oversees the preparation of the annual Translation Committee budget and brings forward requests for budget revisions as needed;
7. Gives Translation Committee reports and presents motions at Area Assemblies;
8. Relays all requests for written translation to the volunteer translators. Note: the Translation Committee fulfills requests received by the Area Secretary and NAGSC and SAGSC secretaries only;
9. Facilitates repair of equipment as needed;
10. Serves on the Area Communications Committee.

B. Alternate Chairperson

1. Attends and participates at Translation Committee meetings;
2. Conducts Translation Committee meetings in the absence of the Chairperson;
3. Attends Area Assemblies;
4. Schedules equipment use requests for Area events (Assemblies, Area Committee Meetings and pre-conference roundtables);
5. Sets up, tests, and oversees equipment operation at all Area Assemblies and, upon request, at Area Committee Meetings;
6. Works with interpreters at Area Assemblies and resolves any immediate needs that may come up during work time (e.g., people talking to them while they are working, where they will be set up, equipment problems etc.);

7. Inventories equipment after each assembly;

C. Secretary

1. Attends and participates at Translation Committee meetings.

2. Takes minutes of all Translation Committee meetings. Sends the minutes to the Translation Committee Chair and Translation Committee members prior to the next meeting;

3. Prepares Translation Committee agenda by communicating with Translation Committee Chair and other Translation Committee members prior to the Translation Committee meeting;

4. Gives the Area Archivist all Translation Committee meeting minutes at the end of the rotation;

D. Depending upon the availability of equipment and interpreters, the Translation Committee Chairperson, Alt. Chairperson or other bi-lingual member should be present at all Area Assemblies and pre-conference roundtables to interpret.

Responsibilities of the Translation Committee

~~The translation committee will be responsible for:~~

~~8. Keeping open communications with Area 42 and the Spanish Linguistic Community.~~

~~9. The translation of documents.~~

~~10. Providing translators during Assemblies.~~

~~11. Providing a budget for expenses; materials, translation equipment, printing and other expenses~~

~~12. Conducting two or more meetings annually.~~

~~13. Presenting a semi-annual report at Area Assemblies.~~

IV. EQUIPMENT POLICIES

A. The Northern and Southern Area Chairs will maintain and store their own equipment. The Chairs are responsible to transport equipment to area assemblies, to insure that batteries are adequately charged and to notify the Translation Committee Chairperson of needed repair work.²

B. The cost of any repair or replacement of the equipment as the result of damage at an Area or NAGSC/SAGSC event will be the responsibility of the Area.

V. FINANCES³

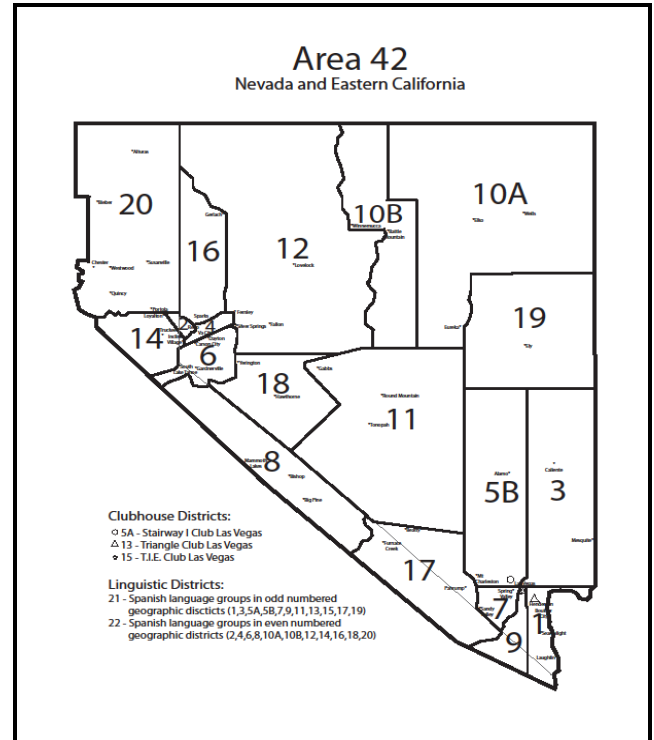

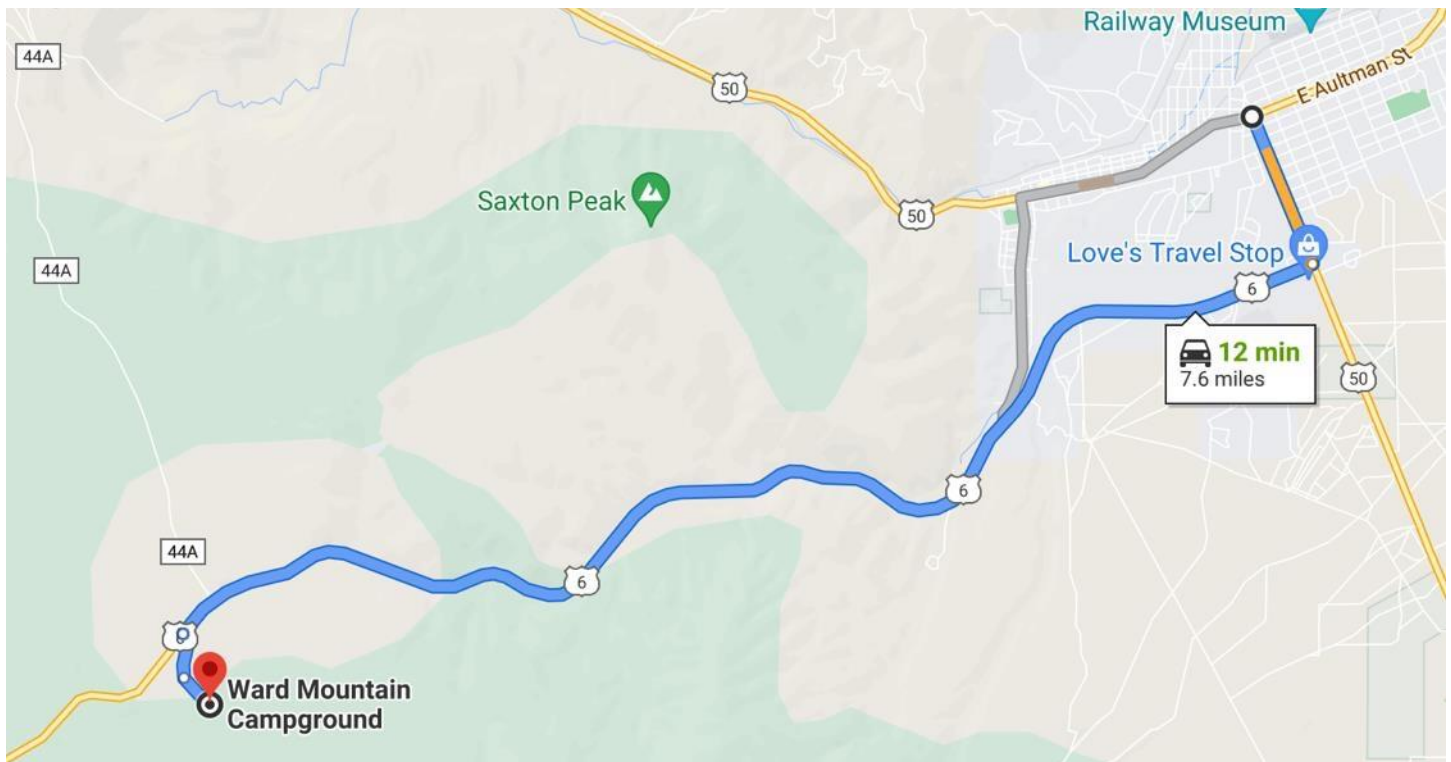
