Limited Officer Reports

Delegate (Julie C.): 4 committee recommendations wrong in ppt.

My name is Julie and I have the honor and privilege to serve as your delegate for Panel 71.

It is my hope that I will give you a brief overview of my experience at the 71st General Service Conference. My intention is to share what I saw, heard and felt. I will cover the items that Area 42 presented at the Southern and Northern roundtables and all the items we discussed at the Preconference Assembly. Please see the Area 42 Delegate's Report Back PowerPoint presentation. For those of you who would like the specifics of what happened with each agenda item from the Conference, please go to the Delegate's Corner on our Area 42 Webpage on our password protected section. Additionally, the Trustee, Conference and Staff reports are available to each of our Area Conference Committees (ACC). If you would like more information, please don't hesitate to contact either me or Jake S, Alternate Delegate.

In summary, the Conference was bold. We took action, but we did so thoughtfully, carefully and respectfully. Most committees moved forward on agenda items that have been discussed for the last few years. Big ticket items were: 4th edition of *Alcohólicos Anónimos;* 5th edition of *Alcoholics Anonymous;* translation of 4th edition of *Alcoholics Anonymous* into plain language; online groups will be able to list with GSO; we have a

new completely revamped service manual; all three Cooperation with the Professional Community items passed and many, many more. Please see the 71st GSC Quick Reference for all the recommendations that the Conference voted on.

Finally, I would like to say what an incredible honor it is to serve Area 42 and Alcoholics Anonymous as a whole. I watched as some items were passed unanimously, some items were passed after a moving minority opinion was given and that we trusted the committee process. I felt the devastation from those when the vote didn't go their way. Most items that the Conference Committees recommended passed with substantial unanimity by the entire Conference. What I experienced was that everyone at the Conference was there because of their love for Alcoholics Anonymous. And we all had A.A.'s best interest at heart. I felt love and hope for our future. I heard the Serenity Prayer in French, Spanish and English. I saw our own Marita get elected as our next U.S. Trustee-at-Large (TAL). I felt the love and respect for each other. Thank you from the bottom of my heart for this absolute privilege.

Questions:

Pat B.: Pamphlet for Mental Health Professional – Did anyone on the committee ask these professionals how they would like to receive this information?

Julie: Yes, and they want it digitally.

Joyce Y: I am excited about new service manual. What will the cost be?

Julie: I don't know.

Phil W.: I am very happy that we are getting a plain language 4th Edition.

Don D.: Did they come to a resolution between the two preamble changes?

Julie: "Men and women" changed to "people," and this will come out in the July Grapevine.

How do you feel about the changes in general? All thumbs up.

Ray C.: I am heartbroken at the direction of the language changes.

Joel B.: Will there be a copy of the conference outcomes?

Julie: I will provide some information in the chat, something will come out at some point, and will hopefully be able to bring it to Tonopah in the Fall. Look at the Delegate's corner on the webpage.

Sophie: What is a floor action and how does it come to be?

Julie: Like the action about the preamble, the committee decided to not move that forward out of committee. A delegate who was not in the committee then puts together a floor action to bring it to the Conference floor anyway. Essentially, the action bypasses the committee.

Joel B.: Do they bring non-alcoholic professionals into the committee meetings?

Julie: We have Class A (non-alcoholic) Trustees. We can call them in. We can call in staff, including digital staff.

Mike P.: Regarding the plain language version of the Big Book – will it be shorter?

Julie: It might be. The plain language 12 Traditions illustrated is shorter.

Ray C.: Regarding the 5th Edition of the Big Book: Are they looking for new story submissions?

Julie: Not yet. That's the only thing that will change.

Ray C.: I have some concerns about Veterans and would like to submit a story.

Joyce Y.: The 12 Traditions are 12 pages, but full pages. Would the pamphlet be half pages?

Julie: Yes, half pages.

Tony A.: Heartbroken about changes. Regarding the 4th Edition of the Spanish Big Book – Will they be looking for stories?

Julie: I will reach out about the 4th Edition of the Spanish and the 5th Edition of the English Big Books.

Registrar (Paul E.):

My main focus right now is setting up the pre-registration for the Area 42 Fall assembly. In the next couple of weeks, you will be receiving an email from our Area 42 secretary if you are an Area 42 officer, Northern Area General Service Conference or Southern Area General Service Conference officer or standing committee chair, or a District Committee Member. If you are a General Service Representative you should get this information forwarded to you from your District Committee Member. If you have not received this information by the end of June, please contact your District Committee Member or me at registrar@nevadaarea42.org. The link to the preregistration will not be on the Area 42 web site per the guidelines. This is a good part for the reason for the proposal that will have a 2nd reading at the Area 42 Fall assembly. Everyone will need to register, regardless if you plan to attend in-person or virtually (on-line), you may register in-person at the Tonopah Convention Center when you arrive. But I am urging you to pre-register as this will be so helpful to the planning for our Area 42 Chair (Lisa), the Alternate Registrar (Jonelle), and me. So that we can have everything run as smooth as possible. This will also be the Area's first attempt at having the Area 42 assembly "hybrid" (virtual and in-person). So if you plan to attend virtually, you will need to pre-register. Pre-registration will close on August 23rd. If you haven't pre-registered by then, you will have to show up in-person and will be able to register and attend in-person. Once pre-registration closes and the Alternate Registrar and I review the list of pre-registrants, we will send out an individual email to each who has pre-registered to attend virtually with the "Zoom" login and password. As I

mentioned earlier, everyone must register even if you plan on being in the same room and logging in through one device. Once again, the more members that pre-register, the better and smoother our Area 42 Fall assembly will be. I look forward to seeing all of you at the Area 42 Fall assembly, whether it be in-person or virtually. Thank you for allowing me to serve.

U.S. Trustee-at-Large (Marita R.):

Thank you, Lyle for inviting me to be with you today. I would like to thank Area 42 for putting my name forward for this service position and Julie, our Delegate, for doing such an incredible job of presenting my résumé.

Please allow me a minute or two to explain what a Trustee is and what we do. As you already know, there are 21 volunteer Trustees who serve in an oversight and custodial function for AA. 7 of them are Non-alcoholic Trustees (Class A) who bring expertise from various fields, making it easier for us to have contact with professionals who may recommend AA to their clients. We also have attorney and financial experts to protect our Fellowship. There are 14 Alcoholic Trustees (Class B – "B"oozers). Four of which are General Service Trustees – usually members who bring a special skill such as publishing, technology, or any talent we may be looking for at the time. There are 6 Regional Trustees from the US and 2 from Canada who bring the regional flavor to the board discussions. Lastly, there are two Trustees-at-Large one from Canada and one from the US (me). All board members serve on several committees, travel to visit the Fellowship at Regional Forums, and attend at least quarterly board meeting. About half act as directors to our two corporate boards (AA World Services, Inc. and Grapevine, Inc.). In addition, the Trustee-at-Large also acts as a Delegate to the World Service Meeting and interacts with all the various AA service structures around the world.

What do we do in those pesky committee meetings? We take the items that passed as recommendations from the conference members and supervise the creation of the policy. Sometimes, we roll up our sleeves and create or edit literature; other times, we may review the finances or listen to what the office is doing on our behalf. We follow the recommendations for the year until we make a report to the Delegate's committees on progress made or recommend that the project is ready to become agenda items for discussion by the Fellowship and voted on by the Conference.

So, what have I been doing? I have been on the job for about a month now. I hope to serve Alcoholics Anonymous for four one-year terms. I currently serve on three committees. In the time I have been on the Board, I have met with the Trustee Literature Committee and Trustee Corrections Committee once and the International Committee which meets bi-weekly to discuss how AA is growing overseas and how we may be of service to them. I have attended two full Board meetings, one of which approved this year's Conference Actions and the other chose a new General Manager for our office. If you have been around awhile, you may remember Bob W., who spoke at our Area 42 Assembly and, previously had my service position. I think he will serve

our Fellowship well. I have also attended a Regional Forum for the Northeast Region and the North-South Connection. A forum, for new General Service Representatives, is when the staff of the General Service Office and Trustees visit the different Areas to give you a personal report on what the General Service Office has been doing and ask what more you need to make your service work more effective.

The North-South Connection was a Spanish-speaking meeting of over 300 AA members from all North and South American remote communities. I heard stories about trying to carry the message and starting a group in places like Tierra del Fuego (the southern tip of Argentina); Yellowknife, Canada; and, as a member called the location, "suburban" Fairbanks, Alaska. One woman told a story of living above the Artic Circle who, weather permitting, takes a boat from her island to a large peninsula where she then can make radio contact to attend a meeting. The stories of AA members around our continent carrying the message under such extreme circumstances was moving. When I thought my heart was full enough to burst, another AA checked in: a loner in Antarctica who waits for the tourists to arrive with hopes of a member to share a few moments with during their visit. There is still so much work 12th step work to be done.

I also participate in a monthly meeting with the World Service Meeting Delegates from North and South America to discuss items such as how we can best use social media to bring AA to those who still need it, as well as other topics affecting this service body's efforts to carry the message, build a strong service structure, print literature, and create their own General Service Offices. There is also country to country sponsorship that takes place at this level easily understood by anyone who has sponsored another member or carried service into a dark district. This month, we heard a report from our Guatemalan brothers who are planning for us to meet there this October. It is a herculean task that they are performing with hopes that we can meet in person again. We have also begun planning a bigger North-South Connections hosted by the General Service Office zoom account so that we can offer it with translation into English. This will allow for more participation by the US remote communities as well. Julie will receive information for this December meeting.

I have taken more time than I should, but I wanted to share a part of this path you set my feet on. Thank you for allowing me to serve.

Business:

Motion to General Service Conference

This requests that the General Service Conference consider developing a pamphlet on the Corrections Correspondence Service to include current and additional Fellowship sharing on the value of Corrections Correspondence Service participation.

Background

This motion was originated by a member of the Caring & Sharing Group in Stead, Nevada. The motion received unanimous approval by the Caring & Sharing Group. The motion was then presented to the District 16 General Service Committee where the motion also received unanimous approval. The motion is now being presented for consideration by the Northern Area General Service Committee.

Sometimes upon incarceration, a still-suffering alcoholic develops a desire to stop drinking. In some cases the inmate may be confined in an institution that has no AA meetings, and sometimes no AA literature. If that suffering inmate contacts our General Service Office, one of the resources we can offer is the Corrections Correspondence Service.

The Corrections Correspondence Service allows an AA member who is not confined in a correctional facility to share recovery experience, strength, and hope with an alcoholic who is confined through written correspondence. This service is coordinated through the Corrections Desk at the General Service Office. The service is made possible by Fellowship members who volunteer to be Corrections Correspondents.

The Corrections Correspondence Service was established by Conference Advisory Action in 1971. Forty-nine years later, Corrections Correspondence is still referred to as "A Very Rewarding, But Rarely Mentioned Form Of 12th Step Work."

When an incarcerated alcoholic requests this service, an "outside" Corrections Correspondent can serve as a vital link to the AA program of recovery.

The staff on the AA Corrections Desk continually describes the Corrections Correspondence Service as "one of our most valuable efforts."¹

In an average year during the 2010 - 2019 period, the General Service Office Corrections Desk connected 1,439 inmate alcoholics who requested this service with "outside" AA Corrections Correspondents. 73% of inmates requesting the service were male.²

There is an ongoing shortage of Fellowship volunteers (particularly men) to serve as corrections correspondents.³ When a shortage of volunteers occurs, inmates requesting an outside correspondent are put on a waiting list until additional volunteers are enrolled in the service. Sometimes inmates wait for up to six months to be connected to an outside correspondent due to this shortage of volunteers.

The General Service Office Corrections Desk sends out pleas to the Fellowship for additional Corrections Correspondence Service volunteers on a regular basis (see attachment 1 [there is no attachment 1]). Usually in the July edition, the *Grapevine* publishes an article, usually entitled "Male Call," announcing the need for additional male Corrections Correspondent volunteers (see attachment 2 [there is no attachment

2]). The Corrections Desk also sends an annual letter to Delegates asking them to announce the need for additional Corrections Correspondence Service volunteers.

There has never been a pamphlet on the Corrections Correspondence Service.

Service Material publication F-26 (see attachment 3 [there is no attachment 3]) serves as the application used to volunteer for Corrections Correspondence Service and provides some information on Corrections Correspondence Service.

Fellowship members who have served as Corrections Correspondents have found this form of 12th Step service to be very rewarding. Fellowship sharing on the value of Corrections Correspondence Service participation can be found in a variety of AA publications such as *Box 459*, the *Grapevine*, and the Corrections Desk publication *Sharing From Behind The Walls*.

It is anticipated that more Fellowship members would volunteer for this service if current and additional Fellowship sharing on why participation is "most rewarding" could be consolidated into a pamphlet on the Corrections Correspondence Service.

Additional participation by new Corrections Correspondence Service volunteers would allow the "hand of AA to be there" when a still suffering alcoholic behind the bars "reaches out for help," instead of being placed on a waiting list.

In addition, in February, the District created a "Service Literature Library" with supplies of service literature available, including the materials new General Service Representatives eventually receive from the General Service Office.
