Hi Everyone and Welcome!

Sean D., Alcoholic.

As of today, the current checking balance is \$6193.25, and savings balance is \$7,514.28 for a combined total of \$13,707.53.

We haven't had any major expenses since the last SAGSC meeting; however, we will be preparing for expenses for the Fall Assembly.

In preparation for funding, the approved budget for the Fall Assembly is funding for: 1 DCM at a cap of \$50 and approximately 20 GSRs at a cap of \$75. Please remember that you go to your group first for assembly funding, then to your district, then to SAGSCs and finally to Area. If you have already been fully funded by your group or district then you would not be eligible for any funding. If you need any forms in preparation for requesting assistance, please see me after the meeting. I will provide these on a first come first serve basis. Once all the forms are handed out and accounted for; you will need to see me after the assembly on Sunday morning in Tonopah for a form and a total of all your expenses for eligibility. If there are funds permitting, I will distri-

bute additional forms on Sunday, September 8th. I will be centrally located, with the Area and North treasurers, located near the back of the hall.

On Budget health, we have reached 65% of budgeted expense pay out for this year. We have received 54% of estimated contributions in group contributions and 7th Tradition. I believe we are on track and healthy.

For Contributions, as a DCM or GSR, please make sure to communicate during your district and group business meetings or directly with your group's treasurer where contributions can be made. Please pick up a handout with the SAGSC PO Box Information from up front.

In other news, Michele H. has had to step down from the Finance Committee so we now have a position open for a Finance Committee commitment. If you are looking for a service commitment and have some finance experience please see me after the meeting for additional information. Also, I have met with the Finance Committee regarding some open items in which Emmie M. has taken the lead and will speak on further with this body.

Delegates Report

I can't thank you enough for bestowing upon me this great honor. I have never felt so connected to AA as when I was representing all of you at the GSC. I'm here to tell you all that each and everyone of you is qualified to be our next Delegate.

I arrived in New York, hungry, lonely and tired, when I picked up my luggage and saw that it had been broken and I had to call an Uber because there were no cabs I quickly escalated to Angry. Two hours later I arrived at the hotel grabbed a sandwich and went to my room, positive that you had picked the wrong person for the job. The next morning, I woke up, got showered and met the pacific region to take the Circler Line Tour. We walked through New York City and I fell in love, the architecture was amazing, and the people were wonderful. The walk and don't walk signs do not mean anything in New York.

After the tour we returned to the Hotel then headed to the conference area where there was a meet n greet. I walked around the meet n Greet collecting buttons and bookmarks from the other delegates. I felt like the deer in the headlights. They suggest you mingle and don't cling to the people you know but I found myself searching for familiar faces and shying away from the ones I didn't know. I felt awkward and alone. We then sat down at round tables and listened to the Remote communities meeting and the 1728 presentations. When I got back to my room to dress for dinner, I was exhausted, spiritually mentally and physically. Still convinced that I was not the person for the job.

Then it happened, we sat down to dinner and Vera from Oregon 58 said, "Every meeting, every picnic, every potluck, every sponsee, sponsor, cup of coffee, roundup, assembly, conference, every phone call and every new-comer qualifies me to be here today". I cried. I knew that it was not me at that table, it was AA as a whole. I knew that you had brought me up one commitment at a time.

The next day we met as an entire group and it was like I was wearing a new pair of glasses; I could see my purpose and the old Rhonda (who talks to everyone) came out. I handed out my Area Buttons and introduced myself to everyone. Then they called Roll. I sat there waiting for my name to be called and was filled with so much emotion. 135 members were present or here. The panel 69 Delegates by region took the stage and presented their two-minute talks about their Area. Over the course of the week I sat next to Maine, Rhode Island, Indiana, Utah, California and Canada.

Monday and Tuesday, we met with our committees to discuss the Agenda items. We deliberated for 6 hours over the Grapevine agenda items and called for more background and the statement of purpose regarding the

Grey pages. It was in that room that I really got to see Concept 3 in full swing, the right of decision. I heard so much more information and different opinions from 7 other areas. My mind raced back and forth. Then finally the Delegate from 44 New Jersey Jeff said its in the Grapevine Charter, we have given the Editor the Editorial Freedom to publish what they think is best for AA. We then Called the New Editor in and asked him if he felt he had the freedom to choose, he said he did not. Since it has gone to the conference so many times, he feels he must follow the conscious of the conference. We decided not to recommend any items to the conference. We cited Editorial Freedom on the Grey Pages.

Lunches and dinners were served everyday and desserts were everywhere! After the committees met, we all me back in the Conference area to hear more Delegates talk about their areas. We were not allowed to discuss agenda items with anyone except our own committees.

Wednesday morning, we took a trip on the Subway to GSO. I walked in and saw the Serenity Prayer written in i don't know how many languages and brail. I was so overwhelmed with Gratitude I started to cry, then I couldn't stop. I kept thinking pull it together Rhonda, but the tears kept rolling. I sat down in a corner by the coffee pot and the man sitting next to me asked if I was ok. I said yes, just grateful. He asked where I was from and I said 42, he said oh, I was Phil's Buddy last year, I said you know Phil? Then just like that I stopped. I felt at home, I felt connected in a way I have never felt. We toured the office and I got lost in Archives. My confession is I got so lost in the Archives I never made it to the Grapevine Department.

Wednesday afternoon we started hearing the report backs and recommendations. I will get to those in a minute. Thursday and Friday, we listened to the committees share what they recommended, and we voted on the recommendations. 7 Floor actions were brought to the floor during these 4 days. They were recorded and to be heard after the regular recommendations were all presented.

Saturday Morning, we had brunch and the Trustees that were rotating out gave their farewell speeches. David Morris Class A Trustee and Finance Guy (He writes the Around the picnic table reports) Talked about his journey with AA and how he gave his time and energy to AA because it saved his wife's life, he cried, she cried, I cried...

One last note before I review the agenda items. I forgot to take my service Manuel with me.

The Human Resources Management conference was especially rewarding as the attendees expressed their gratitude for our presence and some even said they were Friends of Bill themselves. Participation in this conference was a request from GSO and they sent us all of the supplies. Committee volunteers that staffed this event are excited to participate again next year as so many people visited our table and took lots of literature. Many people were also excited to learn about the new meeting app. Both were great opportunities to spread the message and to be of service.

We love to party and are available for any AA event - District Workshops, picnics, etc. We contribute to the Area 42 Newsletter and our local Intergroup Silver Streak. We also work closely with the Accessibilities Committee, District 21, and Al-Anon.

PI and CPC are self supporting committees! Please remind your peeps that when the "Green Can" is passed around at meetings, we need their support to carry the message. If you would like to suggest that your meeting should pass around a "Green Can" and need information or need a "Green Can" to support PI/CPC, please talk to one of us.

IN THE PAST, AREA 42 HAS USED THE AUTOMATIC OR COMPUTER ASSISTED TRANSLATION PROCESS FOR OUR DOCUMENTED ACTIVITIES.

BUT THOSE OF US THAT ARE BILINGUAL HAVE FOUND THAT THAT PROCESS WAS NOT ALWAYS FAITHFUL TO THE TEXT. IT DOES PROVIDES LITERAL TRANSLATION BUT CANNOT DISTINGUISH THE NUANCES. IT CAN BE HELPFUL BUT I CANNOT ASSUME ONE TO ONE MEANING BETWEEN WORDS. WHEN USING THIS AUTOMATIC PROCESS, I FIND IT NECESSARY TO ALWAYS REVIEW & REVISE.

NEW CHAIR, FOR ONLY A WEEK

We met last week regarding central office's notification that they will no longer be funding 3 committees and they will be turning them over to SAGSC. The three committees that currently they fund 50% of are Accessibilities, Intergroup liaison, and Grapevine. So that wil be at the end of the year, so at the end of the year Central Office will close those accounts and they are going to give them to us. right now they have 1 account that they keep the funds or those in. When they close those accounts they are going to send an itemized list to the funds that each committee has in their accounts. Right now we have no figures. Looking at the budget that we have right here currently we contribute \$1375, so we will be doubling that. Taking questions about CPC and PI and H&I, but those are zero since they are self funding. So, another thing along w this we are getting is the guidelines that will need to be reviewed and updated. Currently the guidelines say that we fund 50% so we recommend an ad hoc committee to adjust, review and update the guidelines. More questions about why to have an ad hoc committee? We need help because there are 4 on finance committee. Finance committee requests the chair. Jake will create an ad hoc committee to help the finance committee with guidelines change. We need ad hoc committee to look at the whole thing, not just the finance part.

Q; If we were asked today to fund them do we have the funds to do that? And will that effect the funding for GSRs? Yes, we could, shouldn't currently effect the funding.

Sean: Finance committee is not prepared today to make a statement that we will be able to fund and we do not know all of the effects because we are still waiting on information from Central Office in regards to these three standing committees so we are not going to say yes or no at this time.

Discussion:

Point of Order, we need two readings of the proposal before it is voted for, but we need to read and vote on a budget at our next meeting.

Couldn't we do a special request in January? Guidelines need to be changes before we did this? Or vote on guidelines change at the beginning of the meeting before we approve the budget?

Guidelines change comes in due course, budget is for money that is needed. cant we just create a budget for what we need and then guidelines change to follow?

Read first budget in November and then second reading in January.

The SAGSC treasury will provide funding for the Southern Area Chairperson, Treasurer, Secretary, Registrar and Archivist DCM Coordinator, GSR Trainer, and elected Committee Chairs to the Pacific Region Alcoholics Anonymous Service Assembly (PRAASA), if requested in their budget and funds permitting, provided funding is not otherwise available (Area Officers from Area Funding).
- 1. All PRAASA funding shall be based balance funding formula.
- 2. "Exotic location" funding shall be based on Federal Guidelines.

Vote was called. Majority to change guidelines. Minority opinion called to share. Past treasurer Chuck, finance committee does not have the numbers to carry this yet. Second minority opinion shared we would be able to carry the message to more people funding the committees that have been cut funding. Third, we wont know until January what funding we will be working with. believe this proposal was creating before we had the info about.

Vote called again, passed. Guidelines will be amended.
